- Applicants should have completed Operational Level or Managerial Level.
- Students should have sat for minimum 03 subjects in Operational Level and completed Operational Level.
or
Students should have sat for minimum 02 subjects in Managerial Level and completed Managerial Level.
- Students should have minimum of 02 years recognized practical training or work experience. (Academics, IT, and those working in Management areas will also be considered for the purpose of practical or work experience)
- This qualification will not be applicable to those who obtain full exemptions from CMA exams.
- Registration fee for new applicants - Rs.8000.00.
- CABM holders are required to pay the CABM Annual Subscription on or before 31st December for the ensuing year.

Please note that the experience counted for granting the CABM Qualification will not be considered for the PER Assessment of ACMA Membership. For that, you should maintain the CMA PER Logbook for minimum of three years with relevant experiences.
