BIBM is a partner institute of The University of the West of England, Bristol, one of the leading universities in the United Kingdom. At present, the Institute offers postgraduate and undergraduate programmes in **Business** Administration, Accounting and Finance and Nursing, awarded by The University of the West of England, Bristol (UWE, Bristol).

The Certified Management Accountants of Sri Lanka the national professional management accounting body in Sri Lanka incorporated by an Act of parliament will now provide a dual qualification, a professional qualification, and a university degree with the signing of the Memorandum of Understanding with the Bristol Institute of Business Management to offer the Top Up Degree from the University of the West of England, Bristol-UK (UWE-Bristol, UK).



With the signing of the MOU, students completing the CMA Managerial Level will be eligible for Direct entry into BA (Hons) International Business Management the Top-up program in partnership with the University of the West of England, Bristol- UK (UWE-Bristol, UK).

Students completing the CMA Operational Level with the CABM designation and a minimum of 3 years of working experience to get eligible for the Direct Entry to the Master of Business Administration in partnership with the University of the West of England, Bristol- UK (UWE- Bristol, UK).

Students who successfully complete the CMA Final examination (Strategic Level) will be eligible for direct entry into MSC Accounting and Finance Program in partnership with the University of the West of England Bristol- UK (UWE Bristol, UK)

BIBM students who have completed the MSc Accounting and Finance program in partnership with the University of the West of England, Bristol- UK (UWE -Bristol, UK) will be eligible for exemptions to pursue CMA professional programme.



As we embark on this transformative journey together, we invite all eligible professionals and CMA Sri Lanka students to seize this opportunity to further their education and unlock new possibilities in their career s.
